PERSEVERANCE MATTERS

As Wayside Cross Ministries enjoyed the Lord's blessing during our 86th year I was reminded daily of the need for perseverance. Many begin well, but some struggle when adversity or distractions arise. At WCM we have remained faithful to our historic Bible-based, Christ-centered ministries of transformation and encouragement and the Lord has been with us.

The highlight of the year was the hard work and overwhelming generosity and faithful prayers of WCM supporters. Your support enabled us to begin construction on a much needed new building to house the men's Master's Touch ministry. There were many obstacles to overcome, but with the Lord's help we persevered.

The man Caleb came to mind often this year. He was 85 years old when he enjoyed the fruits of his faith and perseverance. He overcame many obstacles throughout his life which could have shaken his trust in God's promises. "And now, as you see, the Lord has kept me alive, as he said, these forty-five years since the time that the Lord spoke this word to Moses, while Israel was journeying through the wilderness; and here I am today, eighty-five years old." (Joshua 14:10)

Caleb believed God when he was young – as WCM has believed God would transform the lives of men, women and children through the faithfulness of Bible-based, Christ-centered ministry. And Caleb believed God when he was old – seeing the rich reward of his perseverance.

For WCM one thing is abundantly clear – God's faithfulness to the ministries, through generous supporters and perseverance in the work of the Lord.

An example comes to mind of a man named John Stephen Akhwari, a Tanzanian marathon runner who participated in the 1968 Olympic games in Mexico City. During the 26.2 mile race Akhwari began to struggle, he fell and was hurt, dislocating his knee. But he continued to run, bloodied but undeterred by his struggle. He was the last person to finish, almost one hour after the winner. When he was asked why he persevered he responded: "My country did not send me 5,000 miles to start the race; they sent me 5,000 miles to finish the race."

As you look through this Annual Report you will see example after example of perseverance in the Lord's work at WCM.

The Lord has blessed these ministries, those who lead and volunteer together, those who serve and give generously – with perseverance. Thank you for your support throughout the year.

NEW BUILDING UPDATE



On a bright, crisp October day hundreds of friends and supporters of WCM gathered to celebrate the groundbreaking for the much needed new building at 215 East New York Street in Aurora. The new building will house the Master's Touch ministry along with administrative offices for WCM's ministries.

Demolition was completed in the fall of 2013 and new construction began in the cold weather of 2014.



Joining Executive Director James Lukose and the WCM Board of Directors, were U.S. Senator Dick Durbin, Illinois State Senator Jim Oberweis, and Illinois State Representative Linda Chapa LaVia, among many others.



The new 47,000 square foot building will provide much needed counseling areas, a learning center, and updated facilities providing energy and cost savings.

DUNHAM GRANT

The Dunham Fund awarded WCM a grant of \$500,000 toward the construction of the new facility at 215 East New York Street. The grant was ideally timed to help secure the final financial arrangements and enable the beginning of construction.

The John C. Dunham Fund is the largest private foundation in the greater Aurora area. Its mission is to support organizations that work to make the world a safer and more comfortable place, giving special consideration to Aurora - area organizations engaged in providing education and to organizations engaged in assisting individuals to attain heights they may not have attained without the benefit of such assistance.

The Dunham family has a long history of supporting WCM. John C. Dunham's father, Thomas Dunham, served on WCM's board of trustees and as its Chairman, from 1938 to 1940. WCM is grateful for the support and encouragement of this important foundation.

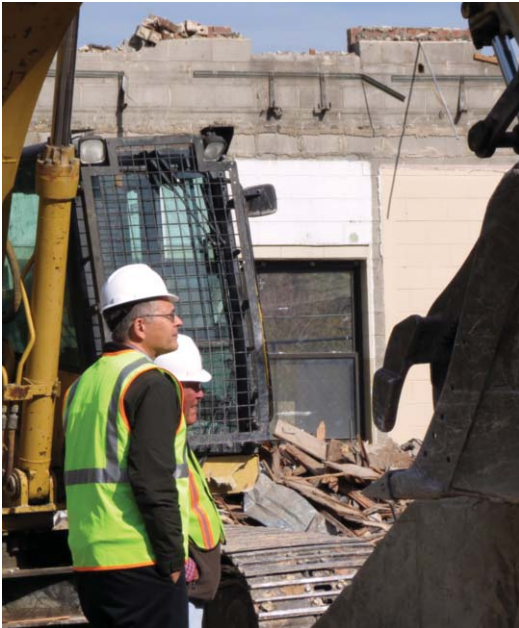
Ken and Gary have been involved with the new building project from its planning stages. They do all of this as volunteers, giving their help to the Lord's work at WCM.

MINISTRY EFFECTIVENESS

Master's Touch Ministry

- 46 men graduated Master's Touch Program
- 16 men completed "Designed for a Work"
- 12 completed "Biblical Financial Freedom"
- 41 graduates found full-time jobs
- 38 men reconciled with wife or family
- 69 men made professions of faith in Christ
- 10 men promoted to full-time resident assistants
- 2 men promoted to Resident Staff
- 7 men resided at our discipleship house - Horizon

Lifespring Ministry

- 66 women and 55 children served, a total of 31 families served
- 17% of women completed the program
- 60% made a profession of faith or rededicated their life to Christ
- 63% showed remarkable improvement in communications skills
- 61% showed remarkable improvement in parenting skills
- 59% received professional counseling
- 60% of Phase III clients obtained jobs
- Currently have contact with 20% of alumni

Urban Youth Ministry

- 4,200 hours of tutoring and homework assistance
- 4,400 meals served to children of low-income families
- 8,700 hours of free summer camp experiences provided
- 575 field trips and day outings
- Free baseball leagues and training clinics provided to 185 youths
- Over 400 new coats, hats, scarves and gloves provided for children

Hope Outreach

- Up to 55 men at one time were provided daily, real-life work experience in our warehouse, transportation department, maintenance shop, and Hope Chest Resale Store
- 8 ministry vehicles maintained with an average of 4,500+ miles per month
- Scheduled, transported, sorted, and refurbished over 400,000 donated items including clothing, furniture, household goods and other miscellaneous objects. These items were sold at the Hope Chest Resale Store or distributed to under-resourced men, women, and children in the community or within one of Wayside's ministries
- Provided 190 families in the community with furniture, clothing, and other basic needs through our Community Outreach program
- Assisted local churches with 74 referrals for clothing, housewares and furniture
- Collaborated with World Relief in Aurora to provide clothing and housewares for 72 refugee families
- 175+ winter coats were distributed to needy families and individuals through a partnership with the City of Aurora and the Aurora Public Schools
- 550 bales at 700 lbs. each of clothing and 1000+ bags of shoes at 40 lbs. each were recycled with the majority of those items going to third world/developing countries
- Partnered with 23 local churches to host Compassion Drives with the purpose of collecting clothes, furniture, and other household items that could be used in our Hope Chest Resale Store as well as other areas of our ministries
- Proceeds from our Hope Chest Resale Store along with our income from recycling clothing, shoes, and scrap metal totaled \$510,245 all of which went to fund the ministry efforts at Wayside Cross Ministries
- Aided in the successful transition of WCM's primary offices in order to prepare for demolition and construction of new building

New Life Corrections Ministry

- Our Weekly Ministry (Dads' Classes, Bible Studies, Counseling) continued in the Kane County Jail, Kendall County Jail, DuPage County Jail, McHenry County Jail, Fox Valley A.T.C., Stateville Prison and the IL Youth Center in St. Charles. For a while, we added the Metropolitan Correctional Center in Chicago to our weekly Dads' Class schedule
- We completed our 43rd 2-Day Dads' Seminar in the Illinois State and Federal Prisons
- 1140 men completed the Dads' Classes/Seminars (884 in 2013); 2415 total since 2010
- 100 Chaplains and Volunteers attended our two One-Day Training Seminars
- 29 attended our two Chaplain's Training Academy sessions; 11 graduated from the 4 week course
- 230 Volunteers are involved (192 in 2012)
- Eight men accepted Team Leadership positions, enabling us to significantly increase our outreaches into the Stateville NRC unit, and the 2-Day Dads' Seminars

Elgin Wayside Center

- 17,160 hot meals served
- 19,020 cups of hot coffee
- 207 NEW individuals received service from Wayside this year
- 62 volunteer hours served on average each week
- 832 Bible studies taught by volunteers

DuPage Initiative

- 1,164 miles of bus transportation provided
- 528 hot lunches provided
- Filled in gaps in the daytime services provided to the homeless by giving shelter and food to at-risk guests
- Helped homeless guests transition to life-change programs or sustainable housing
- Collaborated with and informed DuPage area churches of housing opportunities at Wayside for homeless men, women, and children

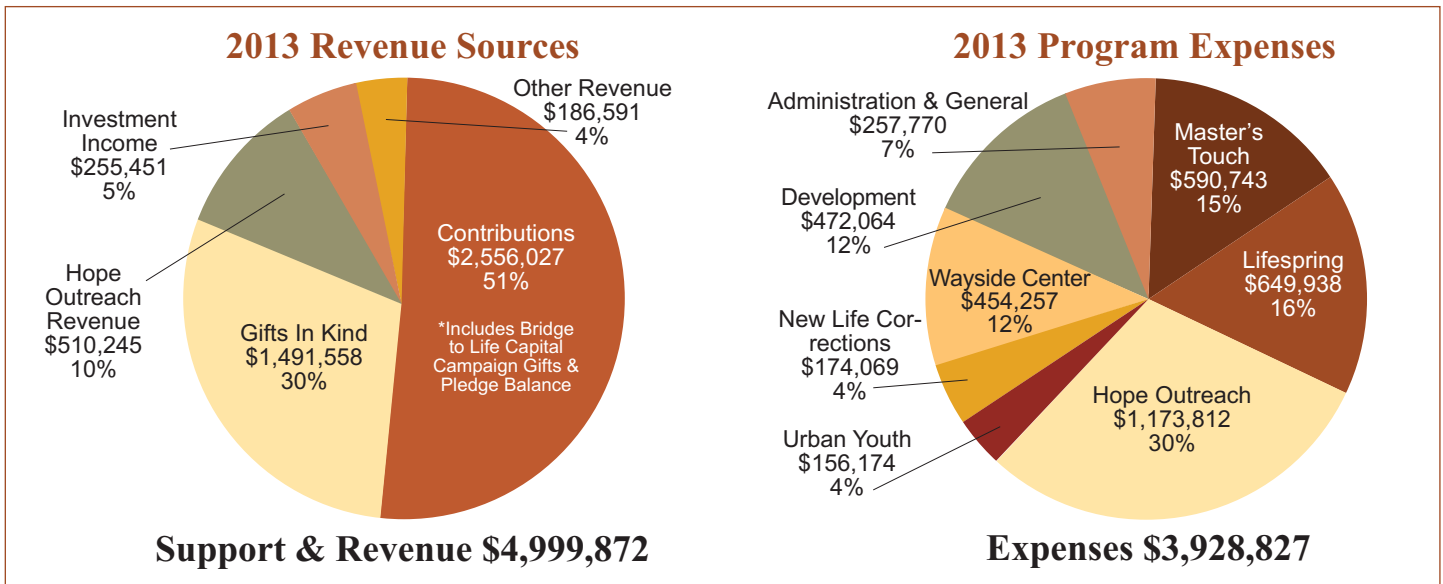

ANNUAL CAMPAIGN UPDATE

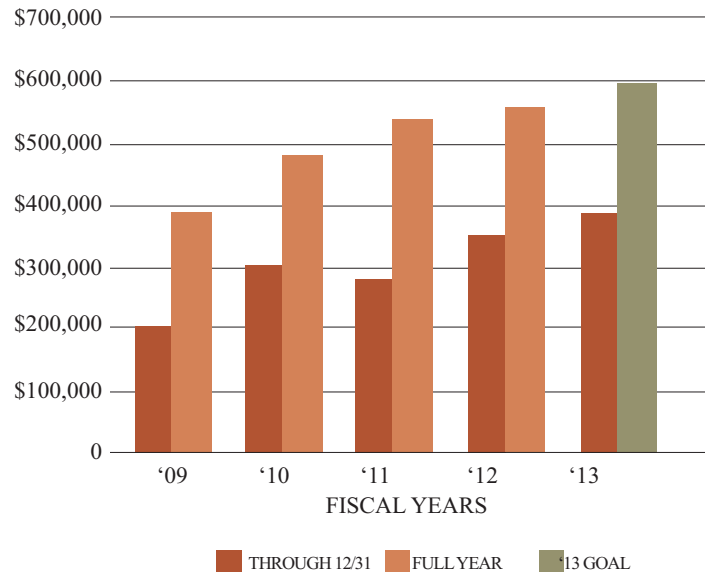
“Keep the celebration going” was the theme for the 2013-2014 Annual Campaign, the eighty-sixth annual campaign conducted by Wayside Cross Ministries. Through February 28, 2014 Wayside’s Annual Campaign supporters have contributed \$468,080. This is \$63,811 or 16%, more than the same period one year ago. Last year’s campaign set a new record for giving and this year’s campaign is on track to exceed that record.

Birnie Harper, Annual Campaign Coordinator, said “Wayside has been blessed throughout its history with loyal and generous donors and that is the reason for the success of the Annual Campaign. The over 300 members of the Heritage Society listed on pages 14 and 15 of this report is a good indication of the support Wayside has received over the years.”

The Annual Campaign also has many volunteers who work to support the campaign. The 2013-2014 campaign has 122 workers who worked very hard to contact previous year donors. Many of the workers have been campaign volunteers for 20, 30 or even 40 years. Their years of assistance is a key part of the campaign’s success.

Wayside Cross Ministries has been helping the hurting, transforming lives and growing for over 85 years, thanks to the generosity of Wayside’s supporters.

MINISTRY UPDATES

Donations to Hope Chest Support the Community

Every shirt, pair of pants, belt, coat, and pair of shoes (even extremely well worn shoes) helps the community through WCM's Hope Outreach division.

When you drop off your used clothing, furniture, electronics, small appliances, housewares, books and toys at the Hope Chest Resale Store on Lincoln Avenue in Aurora, every single item donated helps under-resourced men, women and children in the community.

Through the Community Outreach program 190 families were given clothing, furniture and household items this year. These families come to WCM through a referral program with our partner churches and organizations in the surrounding communities. Items donated also benefit the men, women and children involved in the various ministries and programs internally at WCM.



Christina and her son Isaiah (pictured above) were given infant clothing and furniture shortly after he was born. She expressed deep and genuine gratitude for such a program even existing. A similar reaction can be seen from the refugee families that receive clothing upon entering our country through a partnership with World Relief. The majority of these families are coming from much warmer climates which means that even in the warmer months they might still need sweaters and coats while they adjust.

Your donations to Hope Outreach help those in genuine need, are sold in the Hope Chest Resale Store and support the ministries of WCM, it can even be sold in bales or bags as a commodity - even those old shoes with holes in the soles are put to good use.



AFTERCARE PROGRAM UPDATE

After completing the residential programs of Master's Touch or Lifespring Ministries the transformational work is just beginning in the lives of men and women as they put together a productive and responsible life.

The Aftercare Program is part of WCM's commitment to work alongside residents in essential areas for their success and stability. Led by Dan Olson, the Program address everything from church attendance, educational opportunities and employment to resolving outstanding debts and legal issues.

Tommy – a 2013 Graduate of Master's Touch

Tommy was born and raised in the Aurora area, but his path took him across the country, and in and out of prison three times. He had enough of his own troubles and eagerly pursued Bible study materials and help after his release. Through Chaplain Beatty of New Life Corrections, Tommy was directed to Master's Touch in early 2013.

Tommy is a quiet, man – humbled by his past and his discovery of salvation in Jesus Christ. He attends the Oasis Church in Aurora and has found their encouragement inspiring. He graduated from Master's Touch in November and soon found work through a local temp agency. His excellent work ethic and persevering way made him a valuable employee.

With his good reputation he's been able to find permanent, full-time work, and Tommy has been saving to buy a used car that was donated to WCM to get to his job. With Dan Olson's help, the Aftercare Program has helped Tommy remain stable and live the kind of life he knows the Lord Jesus wants him to live.



Here are the highlights from this year:

- 36 men entered the Aftercare Program since May of 2013
- 100% found a connection with a local church
- 100% received assistance opening a bank account and getting a phone for work
- 75% started the process of securing a Driver's License or State I.D.
- 30% needed assistance with court documents
- 40% sought information about continuing their education
- 60% developed a resume for job applications
- 60% became employed

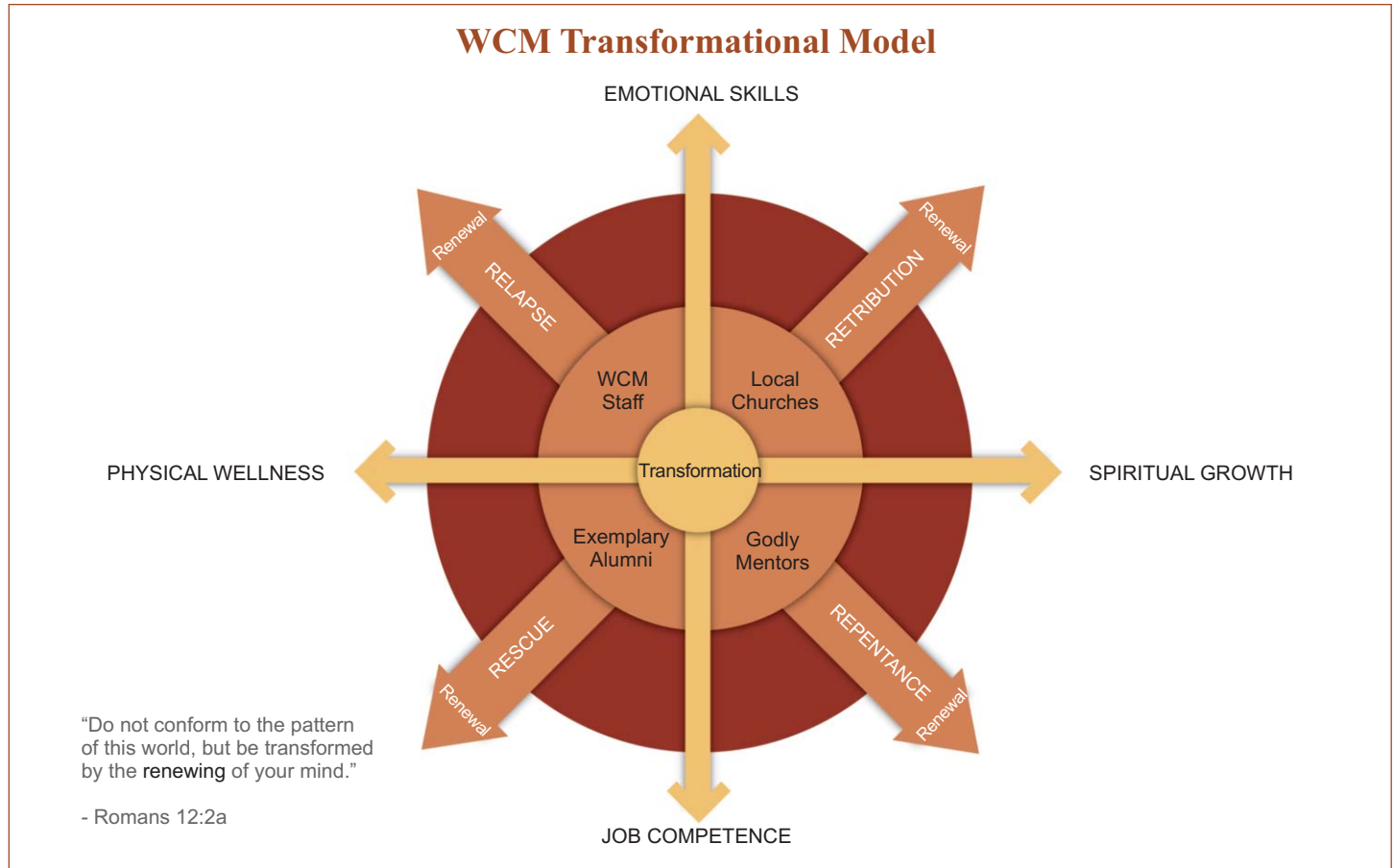
PERSEVERANCE LEADS TO TRANSFORMATION

Over the course of our 85 year existence, many of our *practices* have changed. Starting out in 1928 as a rescue mission for alcohol-abusing men we have grown in to an enterprise of six separate and distinct ministries serving men, women, and children whose lives are in the midst of a wide variety of crises. Yet, our *principles* have, and always will, remain constant: WCM is a Bible-based, Christ-centered, ministry pursuing excellence through the transformed lives of the people we serve, to God’s glory.

Our “transformational model” is holistic, i.e., our ministries address issues not only pertaining to spiritual growth, but pertaining to emotional skills, physical wellness, and job competence, as well. Our model is driven by volunteers from local churches, who fill key ministry roles, such as teaching, mentoring, etc. These ministry “drivers” are supported by our staff, many of whom are WCM alumni.

Transformation does not happen “over night.” It follows a cyclical pattern that is, interestingly, very similar to the cycle that we see in the book of Judges. William Hendricksen describes the cycle with four words: Relapse (Israel’s apostasy), Retribution (the outpouring of God’s retribution), Repentance (changed hearts crying out for forgiveness and deliverance), and Rescue (though the grace of God). In our model, the “relapse” results from any number of circumstances; the cycle goes on from there.

Oftentimes, transformation requires that the cycle be repeated numerous times. Needless to say, persistence on the part of all parties involved is required each and every day here at WCM. We take Paul’s exhortation in Galatians 6:9 very seriously: “Let us not become weary in doing good, for at the proper time we will reap a harvest if we do not give up.”



PLANNED GIVING

Charitable Annuities and the Lord's Work

I have a friend who invested \$1000 in TESLA Motor Company in 2011. After the last few years in the stock market - which has experienced huge gains in the past 12 months, Tesla stock gained 711.61% from November 2011 to the present. His initial \$1000 investment is now worth \$8164.50. Wow!

I keep reminding him not to let the huge gains change his view on the overall portfolio strategy - that of having a diversified long-term approach to his money.

But he always responds that it has been "fun to watch." He doesn't pretend to have predicted this growth, but enjoys the rewards.

Many people experience gains in the assets that they own over time. God has allowed their stewardship to produce fruits through growth. Whether these gains are in the house that they own, investments in the stock or bond markets, businesses they've created or grown, real estate they've purchased, or estates that family has left them, many families face an issue on HOW to continue to make good decisions and be good stewards with God's fruit.

A strategy that is especially attractive today is a Charitable Annuity.

Simply put, here is how a Charitable Annuity works:*

- Work with trusted advisor to donate the appreciated asset
- You receive a deduction on income tax (up to IRS limits based on Adjusted Gross Income) that can be carried forward for 5 years beyond the year of the gift

■ You receive an income stream for life (dependent upon how the asset is managed within the charity) that is typically higher than the dividend/income stream that the current assets pays (based on your age and current interest rates)

■ After you die, the remaining value of the asset passes to the charity or list of charities of your choice

What a GREAT OPPORTUNITY!

Individuals can solve many issues with a Charitable Annuity: disposing of an asset without paying a huge amount of tax; receiving an income stream that will help them meet living expenses; and benefitting an organization that is close to their heart that perhaps they believed was not possible.
